For all permits in all permit categories – If actual costs for review, engineering, inspection, planning and/or legal review plus a township administrative fee exceed the fee paid, the additional amount is the applicant’s responsibility and will be reimbursed to the Township by the applicant.

The permit fee for permits issued after construction/activity has been initiated shall be twice the amount of the required fee for that construction and/or zoning permit.
